# ANNUAL MEETING / CEREMONY

Monday, 27 August 2012 will be the 154<sup>th</sup> anniversary of Freeport's Lincoln-Douglas Debate. This year we will mark the anniversary with two events:

**Annual Membership Meeting** – 6:30 PM in Freeport Public Library. This event will feature the annual financial report and the election of members of the Board of Directors whose terms expire this year.

Annual Commemorative Ceremony – 7 PM in Debate Square [bring lawn chair]. Part of the ceremony will be the unveiling of a plaque in honor of **Robert Schmelzle**. The Society's past president **Robert Plager** will discuss the contributions of President Schmelzle to the Society. In the event of inclement weather, this ceremony will also be held in Freeport Public Library. The **Freeport NJROTC Color Guard** will present and retrieve the National Colors, as well as lead the Pledge of Allegiance.

### PAINTING MYSTERY SOLVED

Journal-Standard article from March 1958 which told of the creation of the paintings.

After contacting Mr. Totz, the following response was received:

What a pleasant surprise after more than half a century. "Lincoln-Douglas" is with us still.

In the summer of 1956 I moved from a studio in Geneva, Illinois by way of Belvidere to Rockford, became involved in the art community, entered the Rockford vicinity art show and received the first prize for a large oil painting. Architect Ed Ware saw the painting and asked if I would be interested in doing a mural for the Lincoln-Douglas Debate. Yes. After some research, I painted a small detailed study in oil which was accepted. We took this to Freeport to the Union Savings Bank, met with the president and all agreed on the size and location of the finished work. Weeks later the completed panels were taken to Freeport and installed. A very satisfying conclusion.

You can imagine my delight in learning what had become of that long ago painting. I am pleased to send you this information on how the "Debate" came into being.

Hopefully this will be helpful for your files.
